

Minutes of GMAG Business Meeting, APS March meeting 2015

Date: Tuesday March 3, 2015, 5:45-6:45PM

Location: San Antonio Convention Center Room 205, session K28.01

1. Election Status: The 2015 Election has not yet been held. Election will be in April. Nominations are needed for the positions of Vice Chair and two Members-at-Large.

2. Secretary/Treasurer's Report. Tiffany Santos described the GMAG finances and membership. Membership has decreased (908 this year compared to 953 last year). Current tally as low as 843.

Funds of \$74,017.01 were available in 2014 compared to \$71,876.71 in 2013, \$62,458.56 in 2012, \$54,713.59 in 2011, \$47,610.47 in 2010 and \$41,253.26 in 2009. There was a net increase in our funds of \$2,140.30, which is much lower than previous years partly due to pay out of outreach funds (\$5,000). Our revenue is \$22,819.95 (investment income, March Meeting income, and membership) and our outlay was \$20,679.65 (meeting meals/facilities, postage, travel, outreach, student awards).

Membership drive: We would like to see our membership at least stay steady instead of decline. Tiffany asked if there is a member of GMAG that is interested in taking on the role of heading our membership drive and discussing and executing ideas with help of the Exec Comm. A budget for any membership recruitment materials will be made available.

The Exec Comm wants the opinion of the GMAG membership regarding this sponsorship.

First question – Where does money for this award come from currently? It comes from general conference funds. There is no specific sponsor recognized.

Axel Hoffmann speaks in favor of the award.

Hari Srikanth: this is the best award at the conference for GMAG to offer

Peter Fischer: suggests setting up a GMAG booth at the MMM because the award does not give enough visibility.

Barry Zink: we can take extra steps to ensure good visibility for GMAG. He is the Joint Conference award chair. We could link the award to the membership drive, by offering free membership to the award winners. He suggested giving free membership when signing up for the competition.

Axel: It's easy to arrange to make the award a high visibility activity at the conference.

Igor Roshchin: Nobody remembers who sponsors awards. How much visibility is there really?

Bob McMichael: This is a trivial amount of money.

Yves concludes that there is a lot of support for it, and the GMAG Exec Comm will be deciding over email how to proceed.

No other issues are raised from the membership.

Mark Stiles is freed from Past Chair duties by Yves.

Jonathan Sun assumes his position as Chair and closes the meeting.

The meeting was adjourned at 6:51 pm.
